

EMDR Cambodia Association Membership

I. Levels of Membership

A. Full Member

- 1) Complete EMDR training certified by EMDR Asia, Europe or other qualify EMDR International.
- 2) Treat at least five clients with using of EMDR full protocol
- 3) Complete at least fifteen hours of supervision with supervisors at EMDR Cambodia Association or any supervisor from EMDR Association in Asia, Europe, or International (a supervision form should be established)
- 4) To be a qualified membership of the EMDR Cambodia Association, the applicant or the member has to be involved in the last two years with; a) clinical experience with EMDR treatment, b) got EMDR professional supervision, and c) obtained EMDR refresher training.
- 5) Pay full membership fee regularly on the yearly basis
- 6) Other nationality can also be a member unless the applicant is not a member of any other EMDR Association.

A1. Membership Renewal Criteria

- a) Member who can continue to renew the membership need to follow:
 - Still practicing clinically by using EMDR therapy at work place every year
 - Got EMDR supervision individual or group from a qualified supervisor in EMDR a supervision form should be established from EMDR Association Cambodia) every year.
 - At least one refresher training/workshop/conference/continue professional development related to EMDR or mental health training within two years.
 - Pay full membership fee regularly on the yearly basis

B. Associate Membership

One of the following criteria will be considered to be an associate membership;

- Those who began EMDR basic training and willing to get involved in the EMDR Cambodia Association activities to promote the mental health OR
- Those who are working in the field of mental health or have been trained in Mental Health Training of the EMDR Cambodia Association and are willing to get involved in the EMDR Cambodia Association activities to promote the mental health OR
- University students who are familiarized with psychological counseling or clinical psychology and are willing to get involved in the EMDR Cambodia Association activities to promote the mental health.
- Pay 50% of the full membership fee regularly on the yearly basis

II. Termination of Membership

A. Self-Termination

- Each of the EMDR Cambodia Association has legal rights to withdraw his/her membership from the association
- To terminate a membership, the member has to submit an official letter to the President of the EMDR Cambodia Association with addressing the reason and the specific time of the termination from the membership.

B. Termination by EMDR Cambodia Association

One of the following reasons can be disqualified and terminated by EMDR Cambodia Association;

- Full Member of the EMDR Association Cambodia who does not fulfill the criteria of its membership.
- Any member of the EMDR Association Cambodia who miss to renew his/her membership with the association every two years. (how about who not renew in one year?? Because we renew in every one year_
- Any member of the EMDR Association Cambodia who misses to follow the code of ethic of his/her professional practice either in local or international standard
- Any member of the EMDR Association Cambodia who violates the internal policy of the EMDR Association Cambodia or his/her work does not go in line with the mission, vision, core value and objectives of the association
- Any member of the EMDR Cambodia Association who exploit, take advantage, damage or harmful to property or asset, or tarnish reputation of the association.

III. Benefits of Being a Member

A) Benefits for Full Member

- Entitled to be a nominee to the presidential election of the association.
- Entitled to get 50% off from the supervision fee from professional supervisor under organizing of the association.
- Entitled to get free of charge of refresher training or professional training in case of funding available
- Entitled to get most up-to-date information on the progress, research article from the association
- Entitled to get involved with the invitation from the management team of the association to the following activities such as conference, workshop, social activity or any other activity that can be suggested by the management team of the association
- Certified by EMDR Association Cambodia as EMDR Therapist.

B) Benefits for Associated Member

- Entitled to get 25% off from the supervision fee from professional supervisor under organizing of the association.
- Entitled to get free of charge of basic mental health training or professional training in case of funding available

- Entitled to get most up-to-date information on the progress, research article from the association
- Entitled to get involved with the invitation from the management team of the association to the following activities such as conference, workshop, social activity or any other activity that can be suggested by the management team of the association

IV. Member's Obligation or Regulation

- Promote mission, vision and reputation of the EMDR Cambodia Association
- Respect and follow the rules and policies of the EMDR Cambodia Association
- Implement EMDR treatment in clinical practice, participate in the professional supervision and go for the EMDR refresher training
- Participate in at least two times of the EMDR Cambodia Association regular member meetings per year. Regular member meeting of EMDR Cambodia Association is set to be held every three months.
- Pay membership fee regularly and based on the type of the member. Membership fee for full member is 50 US Dollars per year
- Renew membership every two years
- The EMDR Cambodia Association members must to follow the code of ethic of his/her professional practice either in local or international standard
- Get involved with any other activities which will be assigned by the management team of the association

V. Quality Assurance

- A technical committee need to be established in order to evaluate or making sure each of EMDR member, except honorable member has been applying or practicing EMDR therapy in a professional manner in his/her daily clinical practice
- The quality assurance has to be based on an international standard either EMDR Asia or EMDR Europe or any other qualified standard.
